

Community Services and its CAP partners are hosting special LIHEAP utility assistance intake events throughout Maricopa County.

A disconnect or past due utility bill is not required to apply for a utility assistance grant. Anyone who resides in Maricopa County and believes their household may be eligible.

Representatives from the city of Phoenix will be on-site and we have an agreement with Mesa CAN to take applications for their residents who may attend the Peoria (3/14) or the Glendale (3/25) event.

To apply for LIHEAP utility assistance, the following must be provided:

1. Applicant only - proof of U.S. citizenship or legal residency in the U.S. (birth certificate, U.S. passport, INS card, etc).
2. Applicant only - Photo I.D.
3. Social Security Cards for ALL household members
4. Current utility bills (SRP, APS, SWG) - If SRP M-Power, printout to show purchases for past 30 days
5. Proof of all income received by any member of your household in the last 30 days including date of application. Examples of acceptable documentation:
 - Employment: All check stubs for last 30 days from day of application
 - DES Cash assistance or General Assistance - DES printout
 - Unemployment benefits- DES printout
 - Child Support- child support printout from court or child support agency
 - Utility Allowance for subsidized housing- printout to show utility allowance
 - Social Security benefits- current award letters for present year
 - VA/Pension benefits- current award letter for present year
 - Self employed- Proof of ledgers/notarized statements
 - School Pell Grants/Scholarships- award letter showing total pell grant/proof of books/tuition paid
 - Zero income - Proof of date last income was received and proof of how needs have been met.

All applicant households must meet the Federal Poverty Level of 200% Gross income received in the past 30-days cannot exceed the monthly amount listed below for the indicated family size.
